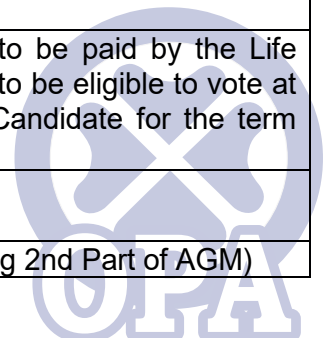

Other Notes:

- Final Voter Lists will be provided on Nomination form Opening Day SUNDAY, 19TH January, 2025
- For all matters of any irregularity, dispute whatsoever, the decision of the Election Committee shall be final and binding.
- Any vacancy of candidate in a group will be co-opted in AGM. Co-opted EC members also have to pay 3000 Taka fees on the day of AGM.
- Mandatory for all candidates (OPA Life Member only) be passed Secondary School Certificate (SSC)/O level (Equivalent) from any School to be duly certified by the SPSC authority or 1st class Gazetted Officers.
- OPA President should bring Original Graduate Certificate on AGM Day to show OPA Election Convener & all elected EC Members

Note: The election will be conducted as per the Constitution & Bye Laws. The Election will be conducted solely by the Election Committee headed by the Principal of SPS as Election Convener & 02 (two) other Co-Conveners to be nominated by the Convener.
